The payment is divided into three parts:

- Booking free (NOK 3 500): Due when ordering. (It is a part of the rental cost.)
- Remaining rent: Due unsolicited at least 36 days before the lease periods first day.
- Deposit (motorhomes NOK 12000 / caravans NOK 6000): Due unsolicited at least 14 days before the lease periods first day.

The deposit includes insurance. If damage or accident occurs, the deductible will be the same as the deposit.

Misfuelling of diesel / water is not covered by the insurance. If this happens, the tenant must pay all costs of repair / replacement. This also applies to other damages that occur due to misuse.

You have to be at least 25 years old to rent/drive our motorhomes/caravans. The motorhome/caravan is without equipment. 250 km per day is included in the rent, beyond this the cost is NOK 3.30 per km.

Expenses for diesel, tolls and ferries you have to pay for yourself. Propane costs are NOK 40 per kilo.

Sanitary liquid and special toilet paper must be purchased by the tenant.

Note! You have to pay VAT and fees in addition if you don't stop and pay in toll booths where there is no Autopass!

The motorhomes and caravans have to be returned clean, outside and inside. If you do not clean it there will be a fee of NOK 1100 for the inside, NOK 750 for the outside and NOK 1 300 for the toilet.

Smoking and pets are not allowed in any of our motorhomes or caravans.

All pickups are Monday to Friday between 14:00 and 15:30 at Bergen Caravan AS, Hylkje, Bergen.

Note! If the motorhome/camper must be collected before 14:00 it must be rented from the day before.

All returns are Monday to Friday between 09:00 and 11:00 at Bergen Caravan AS, Hylkje, Bergen.

Note! If the return of the motorhome/caravan is too late you will have to pay a fee of at least one day's rent.

Bergen Caravan AS is approximately 40 minutes from Bergen Airport, Flesland.

VCU AS is not responsible for any delayed / canceled vacation due to incorrects / mistakes on the caravan / motorhome. We reserve the right to errors and / or changes in pricing and specifications.



Terms and conditions - Vest Caravanutleie AS

1. Rental period

The rental period starts at 14:00 on the first day and ends at 11:00 am on the last day. Late delivery is charged as an extra day and must be paid by tenant when returning. Prolonged rental period must always be agreed with Vest Caravanutleie AS beforehand.

2. Deposit

Deposit for caravans is NOK 6000, for motorhomes NOK 12000. Deposit equals own risk in case of self-caused damage to the caravan/ motor caravan. If the vehicle is found undamaged and clean at check in by Vest Caravanutleie, the deposit will be returned in its full. Misfuelling of diesel / water is not covered by the insurance. If this happens, the tenant must pay all costs of repair / replacement. This also applies to other damages that occur due to misuse.

3. Booking

All bookings must be confirmed by signing the contract, and they are binding for the lessor the last 36 days before arrival. The tenant is responsible for drawing his own cancellation insurance if wanted.

4. Payment terms

The rental price is divided in three different parts:

- Booking fee: paid when booking and will not be refunded in case of cancellation (the booking fee is a part of the rent).
- Remaining rent: must be paid at the latest 36 days before the first rental day. Remaining rent will only be refunded when presenting a medical certificate.
- Deposit: must be paid at the latest 14 days before the first rental day.

5. Take-over and return

The vehicle must be picked up between 14:00 and 15:30 on the first day and returned between 09:00 and 11:00 on the last day. Only Monday to Friday. The caravan/vehicle is clean at take-over and must be returned in the same condition with an empty toilet. If not, it will cost NOK 1100 for cleaning the caravan/vehicle inside, NOK 750 for cleaning the caravan /vehicle outside and NOK 1300 for emptying and cleaning the toilet.

6. Equipment

The caravan/vehicle is equipped with one bottle with propane. Propane costs NOK 40 pr kg and is paid at drop off. The motorhomes/caravans is without equipment. Equipment can be hired for NOK 300 per person per week, and this must always be agreed beforehand.

7. Driver qualifications

All drivers must be at least 25 years old and have had a valid drivers' license for minimum 6 months. The vehicle must only be driven by the persons written as drivers in the contract.

8. Prohibited use

It is not allowed to use the vehicle in/for:

- carrying explosives, poison, radioactive or dangerous goods
- Motor arrangements or vehicle tests
- Criminal actions
- · Subletting or similar

9. Driving abroad

Only after permission from Vest Caravanutleie AS.

10. Repairs

Necessary repairs below NOK 1000 are tenant's responsibility. Larger repairs must be done only after confirmation from Vest Caravanutleie AS. Tenant must always return valid receipts for money refund. Larger repairs will be paid by Vest Caravanutleie AS when tenant is not responsible for the damage. See pt. 14.

11. Accident

Tenant must always contact the police when accidents where question about guilt is unclear, persons are damaged, fire, burglary etc. Also if the damage is estimated to have a cost above NOK 12 000,-. Tenants must deliver his own written description of damages and accidents included drawings, name, address, phone, on participants and registration number on participating vehicles. Vest Caravanutleie AS must be contacted immediately.

12. Insurance protection

All vehicles have comprehensive motor insurance. Tenant is responsible for payment of own risk 12 000,-. All damage due to misuse have to be paid in full by the tenant.

13. Tenant responsibility

- In case of accident, tenant is responsible for own risk payment
- Tenant is responsible to pay tickets gotten in the rental period, i.e. parking tickets, speeding tickets or similar.
- Tenant always has unlimited responsibility for accidents caused by self-made destruction, carelessness, unknowledge in handling and ignorance of this contract.
- Tenant has unlimited responsibility for damages and accidents caused by impaired driving (alcohol/drugs).
- Tenant has unlimited responsibility for damages caused by driving the vehicle on roads with low standard, off road ignoring the vehicle's height, width and length etc.
- By ignoring this contracts point 8, 9, 10 and 12 tenant has unlimited responsibility no matter the question of quilt or cause.

14. Vest Caravanutleies responsibility

• Vest Caravanutleie AS will deliver the vehicle in cleaned condition; waste and freshwater emptied; diesel tank full and one bottle with propane at take-over.

15. Client information will be treated confidential according to good business ethics.

16. Accept

This contract is fully accepted when the first page is signed by tenant and Vest Caravanutleie AS.
